LEARNING OUTCOMES

Students should become acquainted with the different meanings and changing contexts of the concept of "ideology" from Antoine Destutt de Tracy through Karl Marx and Mannheim to Michael Freeden, get to know the evertransforming nature and persistent characteristics of the most common political ideologies (conservatism, liberalism, socialism, nationalism, fascism, communism, anarchism), and of the concepts of political left and right. Thus, students would become equipped with tools and skills to recognize the fundamental problems of describing the political spectrum of a given community, to recognize the features of ideologies and analyse political cleavages.

Tantárgy tartalma:

COURSE DESCRIPTION

The course is an introduction to one of the most fundamental concepts of political theory: the left-right dichotomy. This visual metaphor has been used for 230 years by political thinkers, historians, economists and laymen to describe and categorize political ideas, movements, and ideologies.

It has been argued at different times since the mid-20th century that political left and right had become obsolete (lost its explanatory power and significance), the current worldwide surge in populism gave a new impetus to this view. On the other hand, many scholars still claim the dichotomy has a clearly definable and unchanged substantial meaning.

The course covers relevant literature of political science, political history and history of political ideas (from Norberto Bobbio and Andrew Heywood to Fareed Zakaria and Jacques Rupnik). We will use the newest press articles (e.g. news stories from The Economist) to apply theoretical arguments to contemporary political developments.

EVALUATION

Evaluation will be based with equal weight (30-30-30%) on

- preparedness for the classes evaluated by a short written test in the beginning of each class
- class participation with insightful remarks and summaries of assigned texts
- a written exam at the end of the course with multiple choice and short essay questions

Grades will be translated from the overall performance of the students reflecting awareness of the relevant basic concepts and accomplishment of other learning outcomes according to the following scheme:

- 5 (excellent) student demonstrated confident awareness with minor errors (i.e. minor citation inconsistency; occasional logical error)
- 4 (good) student demonstrated confident awareness of how academic texts are constructed; set the research focus properly; chose a topic and developed a relevant hypothesis; and accomplished the learning outcomes above the standard but with some errors (i.e. citation inconsistency; some logical steps lacking)
- 3 (fair, satisfactory) student demonstrated awareness of how academic texts are constructed; set the research focus properly; chose a research topic and developed a relevant hypothesis but accomplished the learning outcomes with a number of notable errors (i.e. inadequate citation; logical or relational steps lacking; paper unorganized)
- 2 (passing, acceptable) student performance meets the minimum criteria; barely demonstrated awareness of how academic texts are constructed; student set the focus improperly; overall accomplished the learning outcomes poorly
- 1 (fail, unacceptable) student does not meet the assessment criteria; considerable further work is required to earn the credits.
